Questions 1-4 refer to the following diagram


$$
\begin{aligned}
V & =300 \mathrm{~V} \\
B & =0.2 \mathrm{~T} \\
q & =-1.6 \times 10^{-19} \mathrm{C} \\
m & =9.11 \times 10^{-31} \mathrm{~kg}
\end{aligned}
$$

An electron of mass $m$ and charge $q$ is put in a track and accelerated to the right (in the plane of the paper) from rest through a potential difference $V$. The electron then enters a region containing a uniform magnetic field, and makes a $180^{\circ}$ turn in the field to enter a track that is parallel to its initial trajectory. Suppose the system is 2D lying on the ground.

1. In order to enter the destination track what is the direction of the magnetic field?

We will use the Lorentz Force equation, noting that at the point of entry, the force must be upward (since it must point radially inward)

$$
\vec{F}=q \vec{v} \times \vec{B}
$$

Start with your right hand (right hand rule) in the direction of the particle's motion, curl it in the direction necessary to make $\vec{F}$ point upward. This means $\vec{B}$ is into the page.
However, since we are dealing with a negative charge the sign of the B-field should be in the opposite direction.

> The B-field is out of the page
2. What is the speed of the electron?

We can use the fact that $|W|=|q V|$ and the work-kinetic energy theorem to find the total kinetic energy of the particle after it has accelerated through $V$.

$$
\begin{gathered}
q V=\frac{1}{2} m v^{2} \\
v=10.3 \times 10^{6} \mathrm{~m} / \mathrm{s}
\end{gathered}
$$

3. What is the radius of the path?

Equate the Lorentz force (magnetic force) with the centripetal force to get

$$
R=\frac{m v}{q B}=2.85 \times 10^{-4} \mathrm{~m}
$$

Note that the cross product becomes $q v B$ because $\sin (\theta)$ is 1 while $\vec{v}$ and $\vec{B}$ are perpendicular.
4. How much time is spent in the magnetic field?

We use the relation between speed $(v)$, time $(t)$, and distance $(D) t=\frac{D}{v}$, using the circular arc length as $D$ (Here $D$ is $\pi R$ since it's half the circumference of a circle).

$$
t=\pi \frac{R}{v}=8.68 \times 10^{-11} \mathrm{~s}
$$

Questions 5-8 refer to the following diagram


Six resistors are connected to a 15 V battery as shown in the figure $R_{1}=100 \Omega, R_{2}=70 \Omega, R_{3}$ $=50 \Omega, R_{4}=10 \Omega, R_{5}=30 \Omega$ and $R_{6}=20 \Omega$
5. Are $R_{1}$ and $R_{2}$ in series, parallel, both or neither?

Neither; a loop through one does not necessarily go through the other (there are multiple paths), nor can a single loop be drawn around only those two elements.
6. What is the equivalent resistance of the circuit?

Resistors in series add directly, resistors in parallel add like such

$$
\begin{gathered}
\frac{1}{R_{a b}}=\frac{1}{R_{a}}+\frac{1}{R_{b}} \\
R_{456}=10+30+20=60 \\
R_{2456}=\left(\frac{1}{60}+\frac{1}{70}\right)^{-1}=32.31 \\
R_{123456}=32.21+100+50=182.31 \Omega
\end{gathered}
$$

7. What is the voltage across $R_{2}$ ?

Using the previous question, we can solve for the current through the battery using

$$
I_{\text {battery }}=\frac{V}{R_{123456}}=0.0780 \mathrm{~A}
$$

Note that $I_{\text {battery }}$ is also the current through $R_{1}$ and $R_{3}$ because of the junction rule.
Let $I_{1}$ be the current through $R_{2}$. We can now set up a KVL equation on the left loop:


$$
I_{1}=0.04714 \mathrm{~A}
$$

From Problem 6 we know:

$$
\begin{gathered}
V_{2456}=I_{\text {battery }} R_{2456} \\
V_{2456}=2.66 \mathrm{~V}
\end{gathered}
$$

We also know from Problem 6:

$$
\begin{aligned}
& V_{2}=V_{456}=2.66 \mathrm{~V} \\
& V_{R_{2}}=2.66 \mathrm{Volts}
\end{aligned}
$$

8. Say $R_{2}$ was replaced with a bare wire, what would be the voltage of $R_{3}$

Current would not flow through resistors $R_{4}, R_{5}$ and $R_{6}$ because all the current would move through the bare wire. Therefore the voltage of $R_{3}$ can be described as:


Using a KVL equation, we find that the new current through $R_{3}$ is

$$
\begin{gathered}
-15+R_{1} I_{\text {battery }}+R_{3} I_{\text {battery }}=0 \\
I_{\text {battery }}=0.1 \mathrm{~A}
\end{gathered}
$$

Then using Ohm's Law

$$
V_{R_{3}}=5 \text { Volts }
$$

Questions 9-11 refer to the following diagram


Two resistors of equal resistance $(R=20 \Omega)$ are connected to a capacitor $(C=40 \mu F)$ and a battery $(V=5 V)$ as in the figure. In the beginning the switch is open from both positions, a and b , and the capacitor is uncharged.
9. What is the current through the capacitor immediately after the switch is moved to position a?

Create a KVL loop that includes the battery, capacitor, and resistor $R_{2}$.

$$
-V+V_{c}+I_{c} R=0
$$

Immediately after the switch is closed the capacitor acts as a bare wire, therefore:

$$
V_{c}(\text { immediately after })=V_{c}(\text { before })=0 \text { Volts }
$$

Only one of the resistors experiences a current $\left(R_{2}\right)$ since the capacitor is a "bare wire" at first.

$$
\begin{gathered}
V=I_{c} R \\
I_{c}=0.25 \mathrm{~A}
\end{gathered}
$$

10. Calculate the charge on the capacitor after the switch has been in position a for a long time

After a long time, the capacitor is fully charged and has a voltage equal to $R_{1}$ (KVL). The current through $R_{1}$ after a long time is found by

$$
\begin{gathered}
V=I_{\infty}\left(R_{1}+R_{2}\right) \\
I_{\infty}=0.125 \mathrm{~A}
\end{gathered}
$$

Therefore, the voltage across $R_{1}$ is $V_{R}=0.125 * 20=2.5 \mathrm{~V}$
This voltage is equal to the voltage across the capacitor because they are in parallel, so we can use $Q=V C$ to find

$$
Q=C V_{R}=100 \mu \mathrm{C}
$$

11. After the capacitor was fully charged, the switch is moved to position b, discharging the capacitor. What is the time constant of discharging the capacitor?

The time constant is found by $\tau=R_{12} C$. Since the two resistors are in parallel, we can calculate $R_{12}$ using

$$
\begin{aligned}
R_{12} & =\left(\frac{1}{R_{1}}+\frac{1}{R_{2}}\right)^{-1}=10 \\
\tau & =R_{12} C=400 \mu \mathrm{~s}
\end{aligned}
$$

Questions 12-13 refer to the following diagram


Three squares of current-carrying wire are centered at the origin with each side of length $2 a$, as shown, with $a=0.17 \mathrm{~m}$. There is a current $I$ going through each in the counter-clockwise direction as seen looking down the z-axis. A uniform magnetic field with $B=0.12 \mathrm{~T}$ points along the y -axis. The magnitude of the total magnetic moment (for the three loops together) is $\mu=4.5 \mathrm{Tm}^{2}$
12. What is the magnitude of the current $I$ ?

Since this is a square, the area vector has magnitude $|A|=4 a^{2}$.

$$
\begin{gathered}
\mu=N I A \\
4.5=3 I\left(4 a^{2}\right) \\
I=12.976 \mathrm{~A}
\end{gathered}
$$

13. What is the direction of the torque on the loop?

$$
\vec{\tau}=\vec{\mu} \times \vec{B}
$$

Using right hand rule, curl your hand in the direction of current to find that $\vec{\mu}$ points along $+\hat{z}$. Now do $\vec{\mu} \times \vec{B}$ by first pointing your hand in the direction of $\vec{\mu}$ and curling towards the direction of $\vec{B}$. This gives your thumb in the direction of $-\hat{x}$


Questions 14-16 refer to the following situation
A wire loop with mass $m=0.4 \mathrm{~kg}$, width $w=1.5$ m and height $h=0.8 \mathrm{~m}$ is released from rest just above a region of uniform magnetic field $B=2.5$ T directed into the page. There is no magnetic field outside this region. The gravitational force causes the loop to fall and its motion is constrained to the xy-plane (e.g. it falls straight down without rotating). At the moment shown it is observed to be moving downward with speed
 $|v|=1.2 \mathrm{~m} / \mathrm{s}$, and the magnitude of the current induced in the loop is measured to be $I=0.74$ Amps.
14. What is the resistance of the loop?

From prelectures:

$$
\mathcal{E}=v B L=v B(w)=4.5 \mathrm{~V}
$$

Using Ohm's Law we can solve for the resistance:

$$
R=\frac{V}{I}=6.08 \Omega
$$

If this makes perfect sense to you great! However, if you're not satisfied with just plugging and chugging equations here is the actual derivation:
In this question we only consider the fraction of the area that is in the magnetic field We know that induced voltage can be describe by

$$
\mathrm{EMF}=-\frac{d \Phi_{B}}{d t}
$$

Where $\Phi$ is the measured flux, $\Phi=B A(t)=B w y(t)$ where $y(t)$ is the height of the loop in the magnetic field and is described by $y(t)=v t$

Therefore:

$$
\mathrm{EMF}=\left|\frac{d \Phi}{d t}\right|=B w\left(\frac{d y}{d t}\right)=B w v=4.5 \mathrm{~V}
$$

Using Ohm's Law to find the resistance:

$$
R=\frac{\mathrm{EMF}}{I}=6.08 \Omega
$$

15. At the position shown in the figure the induced current in the loop is flowing clockwise or counterclockwise?

Using Lenz' Law, we know that the induced current will be such that the induced field opposes the changing flux. The flux is increasing into the page, therefore, we want an induced field out of the page. Using the right hand rule $(F=q v \times B)$, this means current must be counterclockwise.

Questions 16-17 refer to the following diagram


A generator consists consists of a square loop of wire with length $L=1.5 \mathrm{~m}$ spinning with constant angular velocity $\omega$. A uniform magnetic field $B=0.8 \mathrm{~T}$ is directed in the positive y -direction as shown in the figure.
16. As the loop spins, at which orientation is the peak voltage generated?

We know that peak voltage is achieved when

$$
\mathrm{EMF}=-\frac{d \Phi_{B}}{d t}
$$

The flux as a function of time is

$$
\Phi=A \cdot B=A B \cos (\omega t)
$$

This is because of the fact that when $\theta=0$, the flux is at its maximum, so we need a cosine function. Taking its derivative

$$
\mathrm{EMF}=-\frac{d \Phi}{d t}=A B \omega \sin (\omega t)
$$

Sine reaches its maximum at $90^{\circ}$, therefore peak voltage is when the loop reaches $90^{\circ}$
17. If the peak voltage generated is 250 Volts, what is the angular velocity of the loop?

From the previous question, we know that:

$$
\begin{gathered}
\mathrm{EMF}=-A B \omega \sin (\omega t) \\
\mathrm{EMF}_{\text {max }}=250=A B \omega \\
\omega=139 \mathrm{rad} / \mathrm{sec}
\end{gathered}
$$

Questions 18-19 refer to the following diagram


A current $I=5 \mathrm{mAmps}$ is uniformly distributed over the above wire and pointing out of the page. The outer radius is $b=4 \mathrm{~cm}$ and the inner radius is $a=2 \mathrm{~cm}$
18. What is the current density at a point inside the wire (where positive z points out of the page)?

The current density is given by

$$
J=\frac{I}{A}
$$

Where $A$ is the cross sectional area. Therefore $I=5 \mathrm{mAmps}$ and $A=\pi\left(b^{2}-a^{2}\right)$

$$
J=1.33 \mathrm{~A} / \mathrm{m}^{2}
$$

19. What is the magnitude of the magnetic field at radius $r=3 \mathrm{~cm}$ from the central axis?

Ampere's Law is given by

$$
\oint \vec{B} \cdot \overrightarrow{d l}=\mu_{0} I_{e n c}
$$

Our enclosed loop would be a circle with radius $r$.
Using the current density found in the previous question, we can say that $I_{\text {enc }}=J \pi\left(r^{2}-a^{2}\right)$.
For $d l$, we are using the circumference of the circle: $2 \pi r$
After solving for $B$ :

$$
\begin{gathered}
B=\frac{\mu_{0} J \pi\left(r^{2}-a^{2}\right)}{2 \pi r} \\
B=1.38 \times 10^{-8} \mathrm{~T}
\end{gathered}
$$

Questions 20-21 refer to the following diagram

20. Which of the following expressions computes the magnetic field at point P due only to the right vertical segment of the wire?
a) $-\hat{z} \frac{\mu_{0} I}{4 \pi} \int_{0}^{L} d y \frac{a}{\left(a^{2}+y^{2}\right)^{3 / 2}}$
b) $\hat{x} \frac{\mu_{0} I}{4 \pi} \int_{0}^{L} d y \frac{a}{\left(a^{2}+y^{2}\right)^{3 / 2}}$
c) $-\hat{z} \frac{\mu_{0} I}{4 \pi} \int_{0}^{L} d y \frac{a}{\left(a^{2}+y^{2}\right)}$
d) $\hat{x} \frac{\mu_{0} I}{4 \pi} \int_{0}^{L} d y \frac{a}{\left(a^{2}+y^{2}\right)}$
e) $\hat{z} \frac{\mu_{0} I}{4 \pi} \int_{0}^{L} d y \frac{a}{\left(a^{2}+y^{2}\right)}$

Use the Biot-Savart Law

$$
d \vec{B}=\frac{\mu_{0}}{4 \pi} \frac{I d \vec{l} \times \hat{r}}{r^{2}}
$$

To find $r$ you have to find the distance from point P to the infinitesimal length of wire $(d l)$.


We have to define an angle $\theta$ to relate $d l$ and $r$ in the cross product.
From the diagram above, $r=\sqrt{a^{2}+y^{2}}$ and $d \vec{l} \times \hat{r}=d y \sin (\theta)(-\hat{z})$
Where $\sin (\theta)=\frac{a}{\sqrt{a^{2}+y^{2}}}$

$$
\text { Thus, } \vec{B}=-\hat{z} \frac{\mu_{0} I}{4 \pi} \int_{0}^{L} d y \frac{a}{\left(a^{2}+y^{2}\right)^{3 / 2}}
$$

21. What is the line integral of the B field around the loop C that goes around the square shown in the above figure? $\oint B \cdot d l=$
a) 0
b) $2 \mu_{0} I$
c) $-2 \mu_{0} I$

The answer is A because the total current enclosed is zero, since the current going in from one side is cancelled by the current going out on the other side.
